1. Clubs shall pay annual dues of \$5.00 per member for the GFWC State of Georgia and dues designated by the General Federation of Women's Clubs at \$15.00 per member. (Annual per capita is \$20.00 payable to the GFWC Georgia)
2. The fiscal year shall be from June 1 to May 31.
3. Dues are due June 1 and delinquent after December 31.
4. To comply with General Federation of Women's Clubs, per capita dues paid by new clubs between July 1 and December 31 shall be applied to the current fiscal year. Per capita dues paid by new clubs between January 1 and June 30 shall be applied to the next fiscal year.
5. Each district votes to establish District dues and this rate is listed on the State Treasurer's Worksheet supplied to the State Office.
